Hunter Use Permits

We require a Land Between the Lakes Hunter Use Permit for all hunters age 16 and older - this is in addition to state licenses and tags:

- Hunter Use Permit \$25
- Combo Hunter Use/Backcountry Camping Permit \$50

Both are valid for one year from date of purchase. Purchase permits online at landbetweenthelakes.us under *Reservations & Permits*, at our Welcome Stations, and facilities. These permits will also be available anywhere TN and KY hunting licenses are sold.

Hunter Safety Requirements

All hunters must posses and have proof of successfully completing a hunter safety course according to respective state regulations.

No Pre-Season Calling

Calling or attempting to call turkeys by imitating the sounds of a wild turkey is prohibited by law in Land Between the Lakes from March 1 until the opening of turkey season. Locator calls, such as owl or crow calls, are permitted.

Reduced Road Access

Several public roads are closed to motorized vehicle access from March 30 through the end of turkey season to provide additional "walk-in" areas. Closed roads will be barricaded and highlighted on a map posted at Hunter Check Stations and on our website.

Turkey Banding in Kentucky

Prior to the spring turkey season, the Kentucky Department of Fish and Wildlife Resources trapped and banded turkeys on the Kentucky portion of LBL to assess gobbler harvest rates and population health. If you harvest a banded turkey, please report the band number when you check out your turkey at the LBL check station and on their website at https://fw.ky.gov/Hunt/Pages/ TurkeyBand.aspx

General Guidelines

- 1. Dial **9-1-1** for emergencies.
- 2. See something? Say something. Call 270.924.2000 or Forest Service Law Enforcement at 877.861.2457.
- 3. The Land Between the Lakes Turkey Hunting Fact Sheet is the official document that includes the hunt dates. If other state agencies indicate something different, this document has precedence.
- 4. You are responsible for your own safety.
- 5. Bring your own water and supplies.
- 6. For campfires, use only dead and downed limbs for fuel. Do not bring firewood from outside Land Between the Lakes, as it may introduce devastating pests. Attend the fire at all times and follow Smokey Bear's rules to put the fire out completely. During high fire danger, use fire rings in developed campgrounds only.
- 7. Keep all pets on a 6' or shorter leash at all times.
- 8. Protect yourself from biting bugs and UV sunlight.
- Firearms are strictly prohibited except during established Land Between the Lakes hunting season by legally licensed hunters with permits.
- 10. Respect the Resource leave historical items, plants, and flowers for others to enjoy. This includes respecting the homes of wildlife and our trails and roads during wet conditions.
- 11. Pack it in. Pack it out. Leave no trace behind.
- 12. See our website for *Camping Rules* and *General Hunting Rules*.

Habitat Improvement

The USDA Forest Service continues to partner with the National Wild Turkey Federation to improve wildlife habitat at Land Between the Lakes. Prescribed burns may occur during all seasons of the year. To check status of pending burns, see the *Alerts* page on our website.



Permits

Hunters must carry on their person the following items while hunting at Land Between the Lakes (LBL):

- LBL Quota Hunt Permit (if applicable)
- LBL Hunter Use Permit
- Appropriate state hunting license
- Appropriate state turkey permit
- Hunter safety card as required by state regulations

Hunters may use printed or digital documentation with proof of identity. Permits can not be changed, altered, or transferred to another hunter.

Quota Hunts

To participate in our Quota Turkey Hunt, hunters must apply online during the quota application period in February and be selected in a computer drawing. **To Apply:** landbetweenthelakes.us/hunting

2024 Turkey Hunting Information

Quota & Non-Quota Hunts

Legal firearms include conventional shotguns or muzzle loading shotguns not smaller than .410 gauge or larger than 10 gauge that hold **no more than three shells (Kentucky) or unrestricted number of rounds (Tennessee). Shot size must be #4 or smaller.**

Legal archery equipment must conform to state regulations.

ALL hunters are required to self-check harvested turkeys at the Hunter Check Station or North or South Welcome Stations *before* leaving Land Between the Lakes (LBL).

Safe Hunting Recommendations:

- DO know and practice safe gun handling.
- DO see the beard before you shoot. It will positively identify the legal target.
- DO wear an orange vest when carrying your turkey out of the woods.
- **DON'T** wear any garment which has red, white, blue, or black—it could be mistaken for colors of a turkey.
- **DON'T** hunt hen calls. Stalking such calls could lead to a dangerous encounter with another hunter.
- DON'T use a gobble call. This is dangerous and might attract careless shooters.

Bag Limits:

- Only one turkey with visible beard is allowed in each state portion of Land Between the Lakes (LBL) during spring season and counts toward the state's limit.
- Turkeys taken by youth during the youth-only quota hunt count toward the state's spring bag limit.
- Fall archery turkey season is open during LBL's deer archery season and a one turkey of either sex per hunter per state limit applies. Fall turkey hunting with firearms is <u>not</u> permitted on LBL.

Reporting Your Harvest:

- All turkeys harvested on LBL must be checked at the Hunter Check Station, North Welcome Station, or South Welcome Station <u>before</u> leaving LBL. Self-check forms are available when stations are unstaffed.
- In addition to LBL harvest reporting, hunters must also comply with all Kentucky or Tennessee harvest reporting regulations, i.e. Telecheck.

Rules of the Road:

- Licensed motorized vehicles are permitted on numbered roads only. (36 CFR 261.55(b)). You can find these roads on our *Recreation Maps* and *Motorized Vehicle Use Map* (*MVUM*) online: landbetweenthelakes.us/maps. Other roads are for administrative access only.
- Parking is permitted within one vehicle length of a legal road. Avoid blocking emergency vehicle access to any road or trail.
- Refrain from rutting fields and roads.
- Vehicles classified as off-highway vehicles are only allowed in the Turkey Bay Off-Highway Vehicle Area and require a riding permit.

General Hunting Rules & Regulations:

- Remember to observe all applicable state and federal regulations.
- When transporting firearms in a vehicle, keep them cased and unloaded in both chamber and magazine. (36 CFR 261.53(e))
- Nature Watch Areas, wildlife refuges, safety zones around facilities, and other posted areas are closed to hunting. Maps are available at our facilities and on our website: landbetweenthelakes.us/maps.
- It is unlawful to discharge a firearm or other implement capable of taking human life within 150 yards of a residence, building, campsite, developed recreation site, or occupied area or across or on a Forest Development Road or a body of water adjacent to a road, or in a manner or place whereby any person or property is exposed to injury or damage as a result of such discharge.
- Use of thermal imagery or infrared optics to locate any game species is prohibited.
- Use of any artificial light to locate wildlife is prohibited at all times.
- All portable blinds and trail cameras must have an affixed display of the owner's name, address, and phone number, and may be placed no more than two weeks before hunting season opens. Placement doesn't reserve any site for exclusive use by an individual, as public land is open to all users.
- All blinds and trail cameras must be removed within one week following the close of turkey hunting season.
- The placement of bait or hunting over bait, including food or mineral substances, is prohibited.
- Do not use paint, tape, flagging, or other artificial materials to mark trees, trails, or routes.
- Hunters must not be under the influence of alcohol or controlled substances.
- Do not leave campfire rings/rocks in fields or roads.
- No hog hunting. It is illegal to chase, hunt, transport, or release feral hogs on LBL.
